Sharon Says....

It is time for the annual report of the condition of CLC and I am happy to say the status of the company is looking pretty good! The 2010 report reflects the slow recovery process from the great economic turmoil of 2008-2009. The latter half of 2009 and all of 2010 were the beginning of the recovery. The removal of General Motors Acceptance Corp from the bankruptcy rating status increased the market value of these securities on CLC's annual statement. Although Lehman Brothers and Times Mirror remain in bankruptcy status, their market values improved substantially. These securities generated \$200,000 of unrealized gains and that alone improved our surplus by that amount.

Assets increased by \$5.1 million (11.3%) which continues our growth that began in 2002. Since then we have increased nearly 119%. At the end of 2010 our assets were at \$49,910,178 and since then we have topped the \$50 million mark! It is very important that we continue to promote the sales of life insurance policies. Our solvency ratio also increased in 2010 to 102.58%. The total surplus at the end of 2010 was \$1,254,735. Our Asset Value Reserve (AVR) is now at 100% of its 2010 maximum and future increases will have less impact on our surplus. In addition to surplus we have what we call Member Safety Funds available for the safety of our members. These funds consist of the actual surplus, plus the AVR and the IMR (interest maintenance reserve). The total for these funds at the end of 2010 is \$1,870,470 which is nearly 26% higher than 2009.

The net rate of return on mean invested assets was 6.5% for 2010. Our net investment income was \$2,948,067, 14.4% up from the previous year. 96.4% of our total assets constitute holdings in bonds and 93.7% of the bonds owned by CLC are in the top two investment grades. All bonds purchased by CLC are in the top investment grade at the time of purchase. Our average maturity of bonds is 10 years. The shorter periods to maturity help to maintain the appropriate liquidity and will allow CLC to better take advantage of future market upswings.

CLC experienced new life insurance production of \$2,853,000 making our total insurance in force at \$54,895,000 and a total of 8,486 certificates are now in force. Our annuity income was \$4,370,357 for 2010 which, when added to the insurance premium income, we feel we are at a good level of production. We are constantly monitoring our level of production in relation to the cost of doing new business.

Our General Expenses for 2010 were lower by 15% from 2009 and this helped CLC to have a net gain from operations of \$298,892 compared to a loss of \$35,455 for 2009. Three items helped to lower these expenses and they included salaries and wages down 6.5%, legal fees down 89% and accountant and actuary fees down 32%. Your Board is constantly monitoring the expenses and we are always looking for ways to cut them even more, but being careful to avoid cutting where it could adversely affect operations of the company.

There is a new piece of data that is required by the NAIC, the state of Ohio and the American Fraternal Alliance called the Risk Based Capital (RBC) Calculation. RBC is a method of measuring the minimum amount of capital (surplus) appropriate for a society to support its overall business in consideration of its size and risk profile. Although the regulatory action level is a ratio below 200%, the Ohio Department of Insurance and other insurance departments feel more comfortable if the ratio exceeds 300%. I am happy to report that CLC's ratio is at 328%.

Since CLC experienced a good financial year, your Board is working on a plan to begin the process of paying back the lien. I am confident that we will, with time, be able to pay each of you back what you, our members, have allowed us to borrow. Each day brings new challenges from our peers, but I along with the rest of the Board am determined to overcome each of them and will continue to work to make CLC a very strong fraternal life insurance company! I thank each of you for your hard work in helping us to achieve this. Also, thanks for your faith and trust in CLC!

Twenty-three members attended the May meeting of Council 207 at the Golden Coral Restaurant.

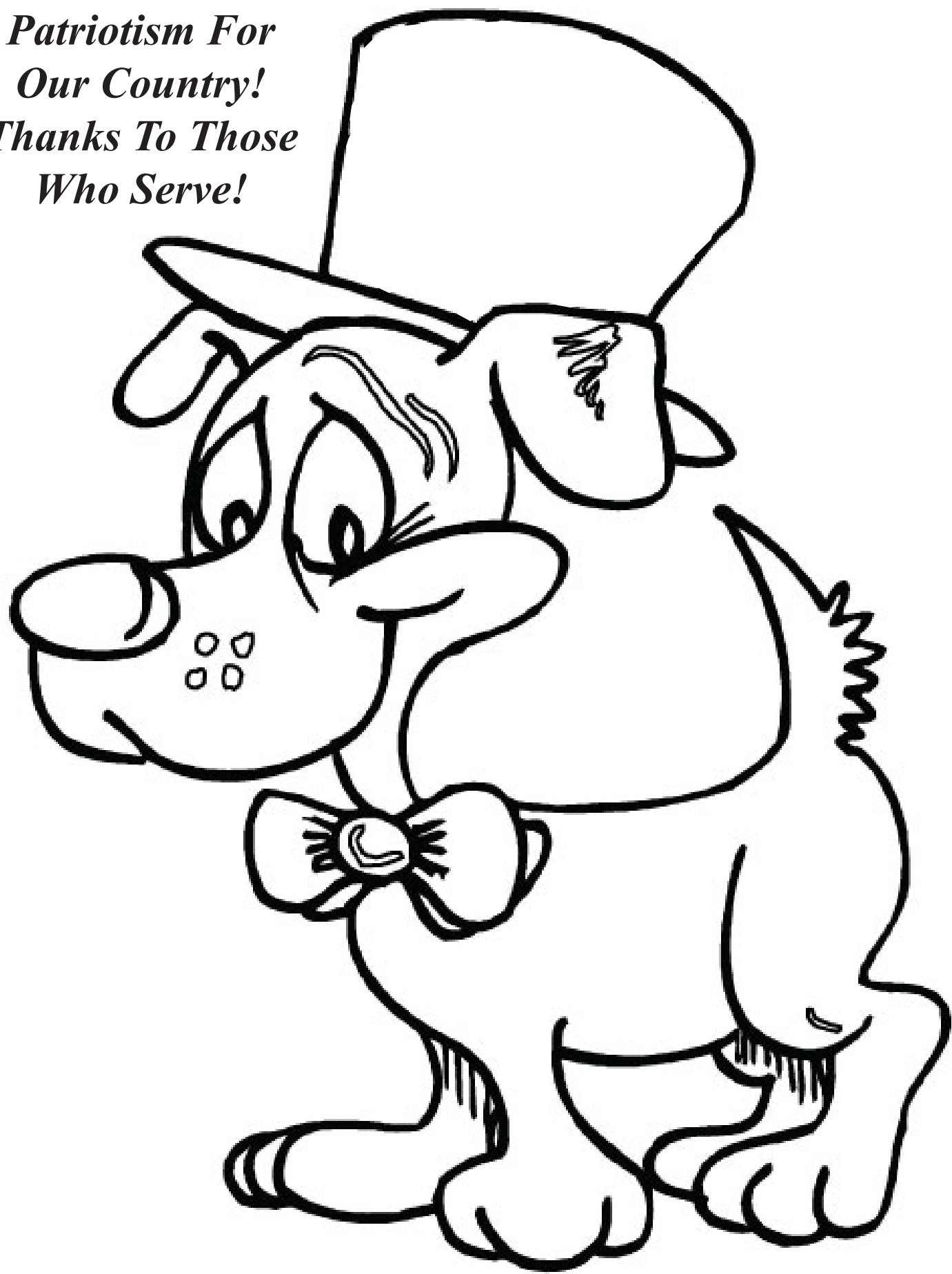
